February 9, 2023 Colona, IL

The regular meeting of the Board of Education was called to order at 6:34 p.m.

The meeting began with the recitation of The Pledge of Allegiance

There were no visitors or individuals present to speak to any agenda item.

Good News Items included a donation from the First Day Fund (Christ Church-East Moline, IL) in the amount of \$500 and a donation to the guardian angel fund from Marsha Timmerman in the amount of \$250.

Dr. Ruff also recognized Miss Jessica Tucker on her recent recognition from the Illinois State Board of Education. Miss Tucker was nominated for her hard work and dedication to the students at Colona Grade School. She received the Illinois State Board of Education Award of Special Recognition.

Jessica Tucker won the Award of Special Recognition as part of the Illinois Teacher of the Year program. January 20 inservice was on data analysis. The April 21st inservice will be on MAP data analysis. Sign up for student-led conferences will be sent home. Dates include March 9 and 10. The 5 essentials survey has been released. Teachers, parents and 4-8th grade students have the opportunity to take this survey. Benchmark testing has been completed and will be shared at conferences. Students have solved 876K math facts!

The Athletic Director shared that girls basketball is underway. The wrestling team recently competed in a tournament at Orion High School. Colona finishers were Blake Trickey in third place and Kylar Swanson in fourth place. Scholastic bowl has also started.

The Colona PTA shared The Breakfast with Santa raised \$1080 and had 202 people in attendance. QC Custom has opened the spirit wear store until 1/31/23. The spring craft fair will be inside. PTA will provide snacks for IAR testing in April. Mrs. Parker and Ms. Tapia received grants for classroom supplies. Scholarship applications will be accepted until March 3. The scholarship night at UTHS will be held the first week of May. The vice president position will be open after this year.

The Maintenance report listed general maintenance performed for the month.

The School Resource Officer reported daily tasks and his schedule. He will continue to monitor handicap parking issues and will introduce some incentives for student behavior. Positive interactions with the students and families are becoming more common with a parent thanking Officer Tony for his interaction with her son.

Summative Designation Presentation for Colona Grade School - Rating of the school report card. Mr. Carlson gave a presentation about the areas of success and areas of improvement for Colona Grade School. Each year students take the IAR test. Colona has received a Commendable rating which falls between exemplary and targeted support. Sub-categories that are also evaluated are: low income, white, hispanic or latino and CWD (children w/ disabilities). Colona received a commendable rating in these sub-categories. Academic indicators that are evaluated are ELL, math growth, ELA proficiency, math proficiency, science proficiency, ELL progress, chronic absenteeism. Colona Grade School will focus on vocabulary, data analysis and curriculum work, professional development for staff, reviewing textbooks for ELA and math.

Bids are out for new security cameras. On February 6, 2023 there was a prebid meeting held in the superintendent's office. Two companies attended. Final bids will be due on Friday, February 17, 2023.

Julie W., Julie A, Dr. Ruff and Edith Glackin met with IASB Director, Tammy Ng for the first meeting to review the preliminary work to customize our Board Policy.

The tree removal project is two thirds done.

Dr. Ruff wanted to discuss dock days with the BOE. A "dock day" refers to a time off request when an employee no longer has those specific days to use (i.e. sick, personal). This topic is only for discussion and to bring it up to the BOE for future discussion/action/negotiations if necessary. Language is included in the respective contracts. Audience participants were given a chance to share their opinions about time off.
